I have the honour to report that on 06/04/2026 at around 5.30 pm to 6.30 pm, one Scooter Honda Activa 4G bearing regn. No. MN06SB6044, Red-M in colour, Chassis No. ME4JF507EH7143033, Engine No. JF50E75143046 & Model-2017 which was purchased in the name of my father- H. Bishwajit Singh S/o Lt. H. Meino Singh, Salungpham Road Wangjing, Thoubal Dist., Manipur-795148 was found stolen away by unknown person while it was parked under proper locked in front of Healing Help, Physiotherapy at Athokpam Awang Leikai and was unable to locate till date.
