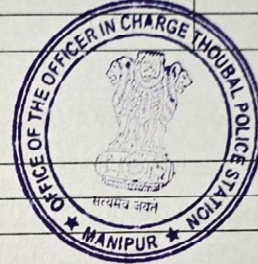

I have the honour to report that today i.e 10/04/2026 at around 8.30 pm, the following persons namely 1) Huirongbam Johny Singh, 37yrs S/o H. Ibohal Singh, 2) Huirongbam Amujao Singh, 53yrs S/o (L) H. Thambal Singh, 3) Huirongbam Abung Singh, 23yrs S/o H. Amujao Singh, 4) Huirongbam Yaima Singh, 21yrs S/o H. Amujao Singh, 5) Huirongbam Tomba Singh, 24yrs S/o H. Ibohal Singh, 6) Huirongbam Sanatomba Meitei, 50yrs S/o (L) H.
