11. First Information contents: On 11/04/2026 at about 8:30 PM, a large number of unknown youths, mostly from Heirok, Wangjing Lamding, Khangabok, and other areas of Thoubal District, assembled and proceeded from Wangjing side towards Police Headquarters, Thoubal in connection with the death of two minors at Tronglaobi violating the prohibitory order issued by District Magistrate, Thoubal dated 11/4/2026 under section 163(1) of BNSS, 2023.

The mob was initially stopped at District Headquarters, Thoubal, where they halted briefly and later proceeded towards Thoubal Melaground. At the Melaground, they raised slogans and again moved towards Wangjing along NH-102.

During the course of movement, the mob turned violent, disturbing public order and obstructing police personnel in discharge of their lawful duties.

Meanwhile, the mob stormed the SP Office, Thoubal and Thoubal Police Station and attacked police personnel on duty by pelting stones and using catapults.

Despite repeated warnings by police to disperse, the mob became more aggressive and continued their violent acts. During the incident, three police personnel sustained injuries and were immediately evacuated to District Hospital, Thoubal for treatment.

As the situation became highly volatile and uncontrollable, police first resorted to firing tear gas shells and subsequently fired a few rounds of live ammunition in the air as a last resort to disperse the mob.

During the operation, arrested five accused persons namely (1) Saikhom Tompok Singh (32) s/o S. Ibungo Singh of Khangabok Sorok Wangma (2) Ningthoujam Mangalsana Singh (26) S/o (L) N. Rajen Singh of Khangabok Khullakpam Leikai (3) Laishram Girani Singh (45) s/o (l) L. Kunjababu Singh of Khangabok Mayai Leikai part ii (4) Khundrakpam Roshan Singh (29) s/o Kh. Budha Singh of Khangabok Moirangpali (5) Phanjoubam Nelson Singh (22) s/o Ph. Ningthou Singh of Andro Kharam Leikai from Khangabok Bazar at about 2:30 AM on 12/04/2026 from Khangabok Bazar for their involvement in committing the crime

The mob was finally dispersed at around 3:30 AM on 12/04/2026 by District Police Thoubal deployed for law and order duty. Hence the case.


