11. First Information contents: On 20/04/2026 at about 8:30 PM, a large number of unknown persons from Thoubal Athokpam, comprising both men and women, assembled at Athokpam Makha Leikai and organised a torch rally and proceeded towards Athokpam Bazar in connection with the death of two minors at Tronglaobi violating the prohibitory order issued by District Magistrate, Thoubal under section 163(1) of BNSS, 2023. Initially, the torch rally was peaceful and dispersed at Athokpam Bazar. However, some unidentified youths within the rally formed an unruly mob and indulged in violent activities by burning tyres and pelting stones using catapults. In the meantime, another group of unidentified youths assembled at Thoubal Melaground, formed an unlawful assembly, and similarly engaged in burning tyres and pelting stones using catapults. Despite repeated warnings by the police to disperse, the mob turned more aggressive and continued their violent acts. As the situation became highly volatile and uncontrollable, police first resorted to firing tear gas shells and subsequently fired a few rounds of live ammunition in the air as a last resort to disperse the mob. The mob was finally dispersed at around 1:40 AM on 21/04/2026 by District Police Thoubal deployed for law and order duty. Hence the case.
