
11. First Information contents: On 20/04/2026 at about 9.30 PM, a large number of number of unknown youth of comprising 40/50 of men assembled at Heirok welcome gate and raised slogan boycotting of CM's visit in connection with inauguration of BDO office by violating the prohibitory order issued by District Magistrate, Thoubal under section 163(1) of BNSS, 2023. The unknown youths created an unruly mob and started proceeding towards BDO, office Wangjing Tekcham Leikai and burned the stage prepared for CM's Visit and also assaulted one VDF member who was on duty there sustained serious injuries on his person and was immediately evacuated to District Hospital, Thoubal for treatment. Despite repeated warnings by police to disperse, the mob became more aggressive and continued their violent acts. As the situation became highly volatile and uncontrollable, police first resorted to firing tear gas shells and subsequently fired a few rounds of live ammunition in the air as a last resort to disperse the mob. The mob was finally dispersed at around 2:10 AM on 21/04/2026 by District Police Thoubal deployed for law and order duty. One Maruti Gypsy bearing regn. no. MN01X6689 allotted to the SPDO, Thoubal was damaged on its left door. Hence the case.
