
11. First Information contents: Today, i.e. 21/04/2026 at about 1:00 PM, during the visit of the Hon'ble Chief Minister for the inaugural function of the newly constructed BDO Office at Wangjing Tekcham Leikai, a large unlawful assembly comprising approximately 1000-2000 individuals, armed with stones and catapults, advanced towards the function site from multiple directions with the apparent intention to vandalize the said office. Despite repeated warnings and appeals by police personnel to disperse, the mob continued to advance aggressively, pelting stones and using catapults, thereby posing a grave threat to public property, dignitaries present, and overall law and order. In view of the escalating situation, non-lethal crowd control measures were initially employed including the use of tear smoke shells and stun grenades as part of minimum necessary force. However, as the mob continued to advance towards the venue, controlled firing was resorted to as a last measure, in strict adherence to established protocols, to disperse the unlawful assembly and neutralize the imminent threat. During the course of the said action, one individual, namely Elangbam Nandbir Singh (40 yrs), resident of Heirok Part-II Elangbam Leirak, reportedly serving as VDF SPO A-Coy and part of the violent mob, sustained injury. Subsequently, the situation was brought under control at about 3:30 PM on the same day, thereby preventing further damage and ensuring the safety of all concerned. Hence the case.
