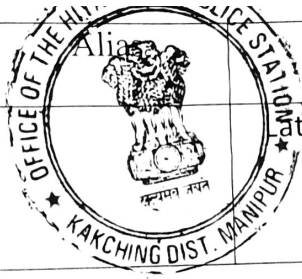

It is to report that today i.e. 11/03/2026 at around 12.30pm. a reliable information was received regarding the presence of banned organization RPF/PLA at Wabagai Kadajit area, Kakching District. On receiving the input, teams of CDO Unit Kakching and a column of 46 AR under the command of Sub. S. Birla Singh, OC-CDO Unit, Kakching, under the supervision of Shri, Amarjit Singh Lamabam, MPS, Addl. SP (ops), Kakching and overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching rushed to the said area and conducted search in the suspected places at Wabagai Kadajit Maning Leikai area. During search operation one suspected individual was detained at the rent House of Laishram Tomba Singh of Wabagai Kadajit Maning Leikai, Hi yanglam, Kakching Dist.

The detainee individual identified himself as Koijam Sanatomba Singh (39) yrs S/o. (L) Koijam Giri Singh of Silchar Banskandi, Assam A/P Wabagai Kadajit Maning Leikai.

On questioning, he disclosed that he is an active cadre of the banned organization RPF/PLA. He joined the said organization in 2008 through one S/S Sergeant Major Lanthaba under Army No.3139 as a Lance Corporal for the said organization. Earlier he was arrested by CDO, Moreh in 2015. Later he re-joined the said organization in June 2023 through one S/S Lieutenant Bonex of the said organization and worked under the command of S/S Lieutenant Bonex of the said banned organization.

On the above admission, the said individual was arrested from the spot at 01.25 p.m., after observing all legal formalities, and videography of the arrest was done at the spot.
