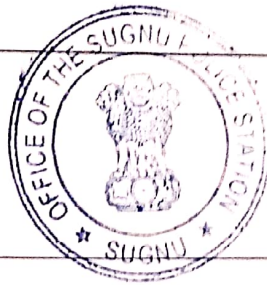

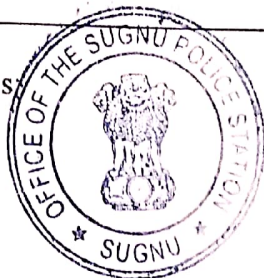

As per endorsement, preliminary enquiry was conducted in connection with the complaint report filled by the complainant namely Manglembi Sankhil (48) w/o Shetkarnong Sankhil of New Chayang, P.S-Waikhong, Chandel District A/P- Umathel Mathak Leikai, PO-Kakching, PS-Waikhong, Kakching District, Manipur.

During the enquiry, examined the complainant namely Manglembi Sankhil and she stated that 07/02/2026 at around 10:30 am, her husband namely Shetkarnong (60 years) S/o (L) Kamtil Sankhil of New Chayang, A/P- Umathel Mathak Leikai, PO-Kakching, PS-Waikhong, District-Kakching and Thingnam Indrajit (40 years) S/o (L) Th. Ibocha Singh of Umathel Awang Leikai, PO-Kakching, PS-Waikhong, Kakching District, Manipur had proceeded towards Sugnu side along Indo-Burma Sugnu road by riding her Vespa ZX (2W Mat Black in colour) B/Regd. No. MN06SG-8517, Chassis No. MET00006A1M015546 and Engine No. M853M3063806 for a work.'

She further stated that at around 12:30 pm, on reaching at Wapokpi Bazar, while her husband namely Shetkarnong (60) yrs was buying some eatable thing from a shop, Thingnam Indrajit had went towards Wapokpi Oil Pump by riding her Vespa ZX to fill petrol in the vehicle. Whereas, the said Thingnam Indrajit did not returned back and he has been hiding at unknown place along with her vehicle by keeping his mobile phone being mobile No. 8974656019 on switch off mode.

During further course of enquiry, visited at the place of occurrence and examined some important witnesses. On examination of the staffs of Wapokpi Oil Pump, they stated that they could not known whether the individual namely Thingnam Indrajit was came at the said Wapokpi oil pump for filling petrol to the vehicle or not. Further, examined the husband of the complainant namely Shetkarnong Sankhil (61 years) S/o (L) SK. Kamtin of New Chayang, Chandel District, Manipur and he also corroborated with the fact and content of the complaint report filled by the complainant.

Hectic efforts has been made from all possible angles to find out the individual namely Thingnam Indrajit (40 years) S/o (L) Th. Ibocha Singh of Umathel Awang Leikai by visited at Umathel Awang Leikai to recover the vehicle. However, there is no any permanent residential house of the individual at Umathel Awang Leikai as per the information collected from the villagers.

Moreover, current location of the individual could not trace out from his mobile phone since he had gone hiding at unknown places along with the vehicle of the complainant by keeping his mobile phone on switch off mode.

From the enquiry conducted so far, it has been reveals that the accused person namely Thingnam Indrajit (40 years) S/o (L) Th. Ibocha Singh of Umathel Awang Leikai, PO-Kakching, PS-Waikhong, Kakching District, Manipur had committed the offences of cheating, criminal breach of trust and dishonest misappropriation of property. Accordingly, there is having sufficient evidence and reasonable grounds to lodge a regular FIR against the accused person for proper investigation of the case.
