Today, i.e. 13/03/2026 at 1.10 p.m, received an information that on the same day at about 12:50 p.m, one Royal Enfield (Medallion Bronze in colour) B/Regd. No. Nil which was coming from Sekmajin Bazar side towards Sekmajin Khunou driven by unknown rider and one Pleasure (Red in colour) B/R No. MN01 L 0700 coming from opposite direction i.e. towards Sekmajin Bazar side driven by unknown rider were collided each other due to rash and negligent driving on both the unknown riders. As a result of which, the unknown drivers of Royal Enfield and Pleasure were received injury on their person and evacuated to Hospital for medical treatment. Both the vehicles i.e. Royal Enfield (Medallion Bronze in colour) B/Regd. No. Nil & Pleasure (Red in colour) MN01 L 0700 were also partly damaged.
