Acting on the input, a combined team of CDO Unit Kakching comprising Kilo-30, K-45 and K-76, led by Sub.Ksh. Prakash Singh, along with a column of 46 AR under the command of Sub. S. Birla Singh, OC/CDO Kakching, and under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Kakching, and the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching District, rushed to the area and conducted a search operation at the suspected locations in Wabagai Thingel Leikai.
