Sir,

I have the honour to state the following few lines for favour of your consideration and kind necessary action please.

I had been a permanent resident of Aihang Village, Chandel Sub-Division, Chandel District. I lived there with my family.

However, the outbreak of the Manipur violence starting from 3rd May, 2023, rendered us to flee from our home and on the 4th May, 2023, our village Aihang was attacked by the Meitei mob and all the houses and other structures of the village were burnt down. In that, a commercial tent house located within the premises of the village community hall and guest house also burnt down. The said tent house was used for providing rental services for various functions taking place in the village and its surrounding areas on payment basis. The said commercial tent house was opened, functioned and registered in my name as I was the General Secretary of the Women's Society of the Village that took custodian role of the said commercial tent house.

After that incident, we had fled for our safety and took refuge at Churachandpur District Headquarters for few weeks. Thereafter, I had spent the remaining of the year 2023, the whole period of 2024 taking care of my mother-in-law namely (L) Themtin Haokip, who was undergaoing medical treatment in Guwahati. During my stay in Guwahati, I had submitted a report for Zero FIR at Basistha Police Station during the month of November, 2024 but it was not accepted. However, I had returned to Churachandpur in the month of January, 2025 as the patient (my mother-in-law) had no chance of living after being diagnosed of Cancer and later died on 16-04-2025. After all these sufferings, I had prepared to lodge Zero FIR, in different Police Stations in Churachandpur District by submitting a report at SP-CCP Office but the same was misplaced and had not reached Police Station.

However, the government is now providing rehabilitation schemes for the IDPs for which registering of FIR is made mandatory for availing such welfare schemes and initiatives.

I, therefore, request you to kindly register an FIR so that my losses are acknowledged and compensated
