I have the honour to report that today i.e. 20/03/2026 at around 11:30 am based on reliable information about the presence of members of banned organization at Waikhong to Kakching Khunou Lamkhai area, Kakching District, 2(two) teams (K-49/93) of CDO Unit, Kakching under the command of Sub. S. Birla Singh OC/CDO Kakching under the supervision of Shri Amarjit Lamabam, Addl. SP(Ops.) Kakching and under the overall supervision of Smt. Priyadarshini Laishram IPS, Superintendent of Police, Kakching immediately rushed to the said area and conducted search operation at Waikhong Uyung Khunou area. During the operation one individual who was matching with the input received was detained by the CDO teams at Waikhong Uyung Khunou area along Indo Burma Sugnu road.

On examination of the individual, the detainee was identified as Laishram Ashok Meitei (42) S/o L. Ibohal Meitei of Pangaltabi Awang Leikai A/P Waikhong Uyung Khunou, PS-Waikhong, Kakching District, Manipur an active cadre of the banned organization KYKL. He joined the banned organization in the year 2000 through one Late Lt. Chaoba Singh and the said banned organization. Further He got Military training for 3(three) months at Chandel Phoulchong under Army No. 7952. On further questioning, he disclosed that some arms and ammunitions were kept and concealed at Bushes nearby his residence located at Waikhong Uyung Khunou. Hence, the said individual was arrested from Waikhong Uyung Khunou at 12:35 pm by observing formalities.

Immediately senior officers are informed and reinforcement teams led by Sub. E. Subhaschandra Singh along with the three others teams arrived and carried out search operation at the suspected area of Waikhong Uyung Khunou Laishram Ashok Meitei residence.
