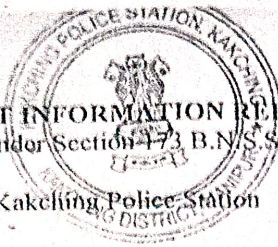

Sir,

I have the honour to report that today, i.e., 26/03/2026, at around 13.00 hrs, a reliable information was received regarding the presence of members of the banned organization RPF/PLA at Kakching Wairi Thongam Leikai, Kakching District. On receiving the input, a team of CDO Unit Kakching comprising Kilo-32 and Kilo-76, under the command of Sub. S. Birla Singh, OC/CDO Kakching, and under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Kakching, and the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching District, rushed to the said area and conducted a search operation in the suspected locations at Kakching Wairi Thongam Leikai.

During the search, one suspected individual, matching the input received, was detained from his residence at Kakching Wairi Thongam Leikai. On preliminary examination, the detainee identified himself as Naorem Johnson Singh (20 years), S/o N. Anoubi Singh, of Kakching Wairi Thongam Leikai. Upon further questioning, he disclosed that he is an active cadre of the banned organization RPF/PLA, and is working under one Jitesh of Kakching Mayai Leikai, who is presently in Myanmar. He further revealed that he has been actively involved in monetary extortion activities in Kakching Bazar, Non-Manipuri Saloon Shops, and Kakching Lamkhai areas.

From his possession, one Redmi 12C mobile phone bearing IMEI-1: 861612066763996 and IMEI-2: 861612066764002, along with JIO SIM No. 9863957791, was recovered and seized at 2.00 p.m. by observing all legal formalities. Videography of the seizure was also done at the spot. Following his admissions, he was arrested at 1.55 p.m., observing all legal formalities as per law.

The arrested individual, along with the seized items, arrest memo, arrest intimation, and grounds of arrest, are hereby handed over to you for further necessary action, please.


