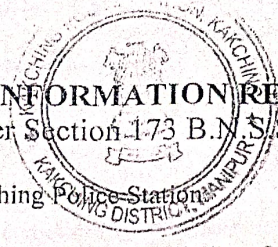

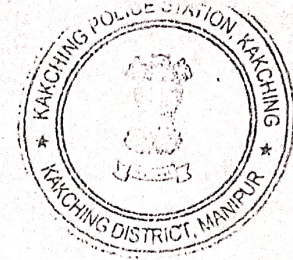

Subject: Complaint report regarding recovery and detention of suspected stolen vehicles during naka checking.

Sir,

I have the honour to report that on 13/04/2026 at about 06:00 hrs, an intensified frisking and checking operation was conducted at Pallel CDO Check Post along Chandel Road in view of the rising incidents of motor vehicle theft in Kakching District and adjoining areas.

During the course of checking, a total of 6 (six) two-wheelers and 1 (one) four-wheeler were intercepted at different intervals and were found in the possession of the individuals mentioned below. However one of the rider of a two wheeler on seeing the police team abandoned his vehicle and fled towards Chandel Lamkang centre side. Upon chasing too the individual could not be apprehended. Upon verification the persons concerned were unable to produce any valid registration certificates, ownership documents, or any supporting papers in respect of the vehicles at the spot.

Considering the suspicious circumstances, the vehicles were initially detained for verification purposes, and the concerned individuals were directed to produce the relevant documents.

However, even after the lapse of nearly 24 hours, i.e., on 14/04/2026, the individuals concerned failed to produce any valid documents or satisfactory explanation regarding lawful ownership or possession of the said vehicles.

Accordingly, all the below-mentioned vehicles along with the persons in whose possession the vehicles were found were brought and handed over to Kakching Police Station for further necessary action.

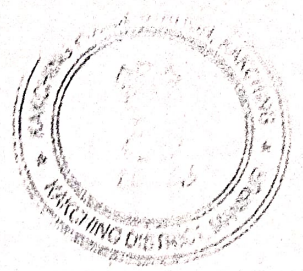
