First Information contents : On 14.04.2026 at around 9:00 pm, I along with my police team while imposing curfew at Yairipok Bazar noticed one 407-TATA Truck bearing Regd. No. MN-05C/4079 driving extremely recklessly from khoirom side. Despite over best attempt to stop the said vehicle it kept on driving recklessly towards Thoubal side so we started persuing the vehicle alerted other naka joints through control room but the said vehicle kept on driving bulldozing through police barricades at Thoubal PS abd also at Khongjom PS. A team of Thoubal PS, two teams of CDO-TBL along with my team chased the said vehicle in an attempt to halt it while also attempting not to cause any accident on the highway. The said vehicle crossed over to Kakching jurisdiction for which we alerted Kakching control room for assistance. At Sora, the said vehicle took a turn at Sora Mamang Leikai and we also kept on persuing it. The said truck was intercepted in the IVR of Sora Mamang Leikai, about 2 KM from the NH-102. The driver was arrested eventually as the back tyre of the truck got stuck in the drain at one of the turning.

While coming out of the said spot, a huge number of the local inhabitants of Sora came out and stoped me and my team from going further. I along with the help of their local leaders tried to convince the growing crowd the purpose of our visit and also not to panic of the situation, They grew violent and started pelting stone upon us. In the process, the driver of my state assigned Govt. vehicle bearing Regn No. MN-01X/2484 got assaulted and got injured. The Gypsy also got damaged. It was at about 10:30 pm – 11:00 pm. The damaged parts of gypsy are as ;

1. Front Bumper of gypsy,
2. Damaged both (left and right) doors,
3. Broken right side door glass,
4. Side glass,
5. Both rear body of the gypsy vehicle,
6. Gypsy hood cover

Hence, a suo moto case under Zero FIR. No. 00(04) 2026 YPK-PS u/s 223/221/132/3(5) BNS, 2023 and sec. 3 Damage to public property Act, 1984 is registered against those persons involved in the assault to my driver and also for causing obstruction to the discharge of the lawful duties as well as damage of public property.


