I have the honour to report that today i.e. 25/02/2026 at about 7.00 p.m, on received of a reliable information regarding likely presence of war like stores at Kakching Khunou, Pamchou hill ranges Pamchou Lamkhai, a combined team comprising of CDO Unit Kakching (K-30,K-43,K-49, K-76 & K-79 led by Sub. Ksh Prakash Singh, one coloumn of 46 AR and a team of Waikhong PS led by SI. A. Sandip Singh under the command of Sub. Soraisham Birla Singh, OC CDO KCG, under the supervision of Amarjit Singh Lamabam, MPS, Addl. SP(Ops), Kakching and the overall supervision of Smt. Priyadarshini Laishram, IPS, Superintendent of Police, Kakching conducted search operation at the suspected areas from 8.15 p.m to 8.50 p.m. During the search operation the area was condoned off and search was conducted at suspected areas.
