Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henry Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Ad.H. SP(Ops) Imphal-East rushed to the said area and conducted a searched operation at the said area at about 01:00 p.m.

As a part of the searched operation random frisking and checking was conducted to the suspected passersby. In that, one suspected person was detained for verification at KhuraiChingangbamLeikai near Community Hall.
