First Information contents: In response to SP/Ukhrul order No. C-1(G/P)/2026-SP(UKL)/1138 dated 02/02/2026, a combined team of Ukhrul Police, 6th Bn. Manipur Rifles, District Forest Department and 18 AR led by Shri. Chongtham Sarjan Singh, MPS, SDPO/JSM, under the supervision of Superintendent of Police, Ukhrul conducted destruction of illegal poppy cultivation at Sihai/Khamasom hill range from 04/02/2026 to 07/02/2026 at 09:20 a.m to 4:30 p.m daily by the order of the Magistrate on duty who furnished Attachment and Destruction order of illicit poppy cultivation in the said area U/S 48 ND & PS Act, 1985 (as amended). An area of about 335 (Three Hundred and Thirty Five) acres approximately was destroyed. It is expected to yield about 3350 (Three Thousand Three Hundred Fifty) Kg of opium. (Calculated at 10 Kg per acre). None came forward to claim the ownership of the cultivated land. Thus, seized some poppy pods for inducing into evidence (if required) in the Court.

Hence, a Suo- Moto case under **FIR No. 02(02)2026/UKL-PS, U/s 18 (b) ND & PS Act** was registered and endorsed to ASI. N Rodeep Singh for investigation.
