Somendro Singh received specific information from 165 TA to SAFE/TBL (special action force for extortion) that some active members of KYKL, a banned unlawful organisation are loitering in and around Kairembikhok area. Acting on the information, organised a joint team of CDO Unit/Thoubal led by Inspt. K. Nitarnan Singh OC, CDO Unit/Thoubal under the supervision of Shri Hijam Devendra Singh, MPS, Addl. SP(Ops)/Thoubal and under the overall supervision of SP/Thoubal District and a column of 46 AR immediately rushed to the Kairembikhok Mamang Leikai Chingdum area at about 06:30 p.m. and conducted frisking and checking of suspected persons. In that, one unknown person was seen in a very suspicious manner. On his suspicion nature, the unknown person was detained for verification. On preliminary</p>			

verification, he identified himself as Khumanthem Santosh Meitei @ Kanta (36) yrs. S/o Kh. Shamo Meitei of Heirok Part-I, Heituppokpi S/S Sergeant of KYKL, a banned unlawful organization. On his body search 1(one) Redmi 9 Power mobile handset along with two JIO SIM card bearing mobile numbers 9863740962 and 8132063236 were recovered from his possession. On spot verification, he disclosed that he joined KYKL in the month of June, 2007 through one Korounganba of their organization. He got 75(seventy five) days basic military training at Tanan, Myanmar under Army No. 578 of 25th batch. He got promotion to the rank of Sergeant in 2018 and worked in 2nd Bn. of KYKL under the command of one Yaiphaba S/S 2nd Lieutenant. He was arrested by Heingang PS in 2020 and 2022 by CDO/TBL. After releasing on bail, he again re-joined KYKL in the year 2023 through S/S Major Luckyson of KYKL. He is working under the command of S/S Major Luckyson of their organization. Further he also disclosed that he was involved Mediation under the instruction of S/S Major Luckyson of their organization. Hence, he was arrested at 07:48 p.m. of 13/02/2026 from Kairembikhok Mamang Leikai Chingdum by observing formalities and seized the above mentioned 1(one) Redmi 9 Power mobile handset along with two JIO SIM card bearing mobile. Hence the case.

SP(Ops.), Thoubal and under the overall supervision of SP/Thoubal and a column of 33 AR, immediately rushed to Yairipok Khoirom Mathak Leikai area at around 03:45 p.m. and conducted search operation of some suspected areas. In that, one person was seen standing in a very suspicious manner and he was detained for verification. Further he disclosed that he was involved in trying to recruit local youth into the organisation by offering various facilities under the instruction of S/S Lieutenant Mr. Mayanglambam Kiran Singh @ Shanti @Boipu of their organization. Hence, he was arrested at 04:00 p.m. of 14/02/2026 from Yairipok Khoirom Mathak Leikai near his house by observing formalities and seized the above mentioned articles at 05:26 p.m. of the same day at DHQ Thoubal by observing formalities. On follow up action, the joint team immediately rushed at Pechi Khunou at around 04:40 p.m. and arrested S/S Lieutenant Mayanglambam Kiran Singh @ Shanti @ Boipu (48) yrs. s/o. M.
