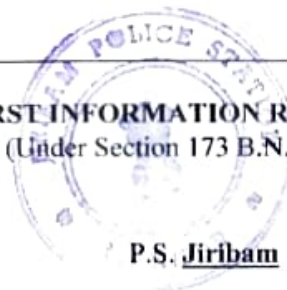

With due respect, I am to report that due to the continuous firing between Kuki and Meitei groups in my village i.e. Mongbung, Jarolpokpi, Jiribam District, Manipur, I had abandoned my house on 7th July, 2024 along with all other villagers due to threat and violence. As we had fled for our safety, our village remained prone to theft and violence and in the process my household properties Rs. 1,00,000/- were either vandalized or stolen away.

During the course of the prevailing violence, I had not filed FIR as I was unaware that lodging of FIR is important. However, of late, the government is providing various welfare schemes and assistances and for availing such government's initiative as an IDP, filing of FIR is made mandatory.

Feeling aggrieved, I have no other option but to report the matter to your good office with the hope that necessary legal action is being taken to compensate my loss.
