That on 7th March 2026, at about 7:30 PM, while I was present at Sabughat, Jiribam District, Manipur, near the residence of Mr. Batte House Sabughat (problem area), Shri Ranajit Barmon, S/o Boven Barmon, resident of Borogao, Lakhinagar, Cachar District, Assam, fired a shot from a locally made firearm with the intention to target and cause harm to me. I narrowly escaped the attack without any physical injury.

This act is extremely serious, unlawful, and has caused me grave fear and poses a serious threat to my life and safety.
