CRPF regarding transportation of some illegal contraband drugs in a TVS NTORQ bearing regn. No. AS 11X-9252 from Chotobekra towards Latingkhal, Jiribam along JT road. Accordingly, I had recorded the statement of the source man and reduced in writing and a similar copy of the source report is also submitted to the Superintendent of Police, Jiribam, Manipur (through proper channel) for necessary information. As such, I obtained search authorization from SP/JBM and immediately, acting on that information a combined team of Jiribam -PS led by myself and a team of 48 Bn. CRPF are authorized to place the NAKA check point at Makhabasti along JT road. Accordingly, conducted frisking and checking of vehicles plying at the said area. On the same day at around 10.30 am, one two wheeler vehicle approached towards the NAKA point Chotobekra side heading towards Latingkhal side driven by one unknown person carrying a backpack bag (Grey & Blue in colour). Later on, the two wheeler has been recognized as the above noted vehicle i.e., TVS NTORQ bearing regn. No. AS 11X-9252 and the rider of the said vehicle is identified as one Sehkhohlen (DoB- 18/02/1974) S/O. Doukholam of Saikulphai village, PO- Borobekra, PS & Dist.- Pherzawl, Manipur. As being suspected of carrying some contraband items, I introduced myself to him and then an option report is also provided to the said person, moreover his legal rights is also informed that, whether may be searched before a Magistrate or Gazetted officer, in which expressed to be searched before an Executive Magistrate. In the meantime have also approached to a person (who is passes by the area) with a request to be witnessing while observing formalities. In which, the said person who accepted my proposal and also identified himself as one Atar Ali (38) yrs S/O. Huti Mia of Ahmedabad part-II, Jiribam.

In no time, the SP/JBM Shri. Prakhar Pandey (IPS) along with OC/JBM-PS Shri. Jitendra Prasad Keer, IPS (P) assisted by Shri, Thingbaijam Kamaljit Singh (MPS), Addl. SP (L/O), Jiribam and Shri. Noor Kamaal Sheikh (MPS), SDPO/JBM accompanied one Executive Magistrate/JBM (later known his name as) Shri. Atom Bijendro Singh were all arrived at the place of occurrence.

On their arrival, immediately carried out checking of the said individual and the backpack bag. On opening of the said backpack bag, 3 (three) nos. of transparent plastic polythene are found inside in presence of the Executive Magistrate and the civil witness. On further opening of all the transparent plastic polythene it is found containing some dried herbs which is highly suspected to be contraband ganja. Then, on further opening of the tool box of the said 2-wheeler vehicle it is also found similar packets wrapped with black plastic polythene and inside it is also found containing some dried herbs which is highly suspected to be contraband ganja. Altogether, 5 (five) nos. of plastic polythene are found containing dried herbs which is highly suspected to be contraband ganja. Being the area is isolated and on the other hand, viewing the prevailing law & order situation, all the required formalities couldn't be made at the said location. Moreover, for the safety concerned of the detainee, he along with all the contraband items and the involved vehicle were brought at Jiribam Police Station for observing further necessary formalities.



On arrival at the Jiribam Police Station, all the 5 (five) nos. of plastic polythene which contained dried herbs are marked as "A", "B", "C" "D" & "E" and simultaneously all the packets are weighed one after another by using electronic weighing machine and found as "A" = 1.059 kg, "B" = 1.039 kg, "C" = 1.034 kg, "D" = 1.042 kg and "E" = 1.052 kg (altogether 5.226 kgs including polythene bag).

Thereafter, all the 5 (five) nos. of plastic polythene which are marked as "A", "B", "C" "D" & "E" and the said backpack bag (Grey & Blue in colour having label of American Tourister) are all put inside a cartoon box and wrapped with white plain cloth with packed and sealed by using wax and marked as "X". Then, I along with the detainee and the witnesses were appended our respective signatures on that cartoon box marked as "X".

Accordingly, the said cartoon box marked as "X" containing suspected contraband ganja, the said 2-wheeler vehicle i.e. TVS NTORQ bearing regn. No. AS 11X 9252 and One mobile phone handset (Redmi A4 5G) are seized at the campus of Jiribam Police Station from the possession of the detainee at 3.20 pm by preparing a formal seizure memo in presence of witnesses. Then, on that seizure memo I along with the detainee and the witnesses (including the civilian) were appended our respective signatures. As well as, the said detainee namely Sehkhohlen (DoB- 18/02/1974) S/O. Doukholam of Saikulphai village, PO-Borobekra, PS & Dist.- Pherzawl, Manipur is also arrested at 3.30 pm and the ground of arrest u/s. 47(1) BNSS had been served to the arrested person and also given arrest information to his family members by telephonically of the same day.
