Sir,

I have the honour to state that today i.e. 03/03/2026 at about 10:40 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of PREPAK (Pro) organization (a faction of PREPAK organization), an outlawed banned organization, in and around Langol area under Lamphel PS with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and Shri K. Dineshkumar Singh, MPS, Dy. SP(CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Langol area. During that one suspected person was detained at a house located at Wangdei Meitei Leikai, Langol for verification. On spot verification, the detainee identified himself as Achom Luwangba Meitei (44 yrs.) S/o. (L) A. Bidhu Singh of Thangmeiband Polem Leikai, Imphal West District, Manipur a/p Langol Yumjaomanbi Leikai, Imphal West District, Manipur.

During preliminary verification, he disclosed that he is an active member of PREPAK (Pro) organization (a faction of PREPAK organization) and presently working under the command of one s/s Commander Chaoba (Ph. nos. +8801344558900 / +8801917326570 / +8801980829071 / 008801301996096 / +8801706498428 / +8801815212044 / +8801764301601) of PREPAK (Pro) organization. He also disclosed that under the instruction of his commander, he was involved in transaction of extortion money of PREPAK (Pro) organization. He further disclosed that under the instruction of his commander, he received extortion money from unknown persons by using his Gpay no. 9089944507 and different bank account numbers i.e. (i) his Indian Overseas Bank Account No. 073201000014801 (Imphal Branch) (as disclosed by him), (ii) his Punjab National Bank Account (Porompat Branch), (iii) his wife's (Bimota) Punjab National Bank Account (Lamphel Branch), (iv) his mother-in-law's (Bimola) Punjab National Bank Account (Porompat Branch) and (v) his son's (David) Indian Overseas Bank Account (Imphal Branch) and he further sent the extortion money to the members/cadres of their party by using his Gpay no. 9089944507 as instructed by his commander.

Hence, he was arrested from the spot i.e. at a house located at Wangdei Meitei Leikai, Langol at 12:45 pm by observing formalities.

From his possession, (i) one vivo 1951 mobile handset along with two Airtel SIM cards bearing mobile nos. (a) 7005695783 and (b) 9089944507 (as disclosed by him) and (ii) one Aadhaar card bearing no. 5920 1546 5379 were seized at the spot at 12:50 pm by observing due formalities.

On thorough verification, he disclosed that he also used another 3 (three) mobile handsets in transaction of extortion money of PREPAK (Pro) organization and later on, his family members were informed to bring the remaining three mobile handsets to the office of CDO-IW, Minuthong. Accordingly, his family members along with his wife namely Thokchom Bimota brought the above mentioned remaining three mobile handsets and as pointed out by the arrestee, the following three mobile handsets (which were used by him in transaction of the extortion money) were recovered: (i) one OPPO A77s mobile handset along with one Airtel SIM card bearing mobile no. 8974567443 (as disclosed by him), (ii) one OPPO F19 mobile handset along with two SIM cards i.e., (a) one Jio SIM card bearing mobile no. 7627917271 (as disclosed by him) and (b) one Airtel SIM card bearing mobile no. 9362321469 (as disclosed by him) and (iii) one Redmi A5 mobile handset along with one Jio SIM card bearing mobile no. 9089268578 (as disclosed by him).

The above recovered three mobile handsets were seized at the office complex of CDO-IW, Minuthong at 03:44 pm by observing due formalities.

Hence, the arrested person and the above seized articles are handed over to you for taking further necessary legal action against him.
