As per endorsed, I have conducted a discreet enquiry u/s 173(3) BNSS, 2023 regarding one complaint report submitted by Kshetrimayum Haripriya Devi aged about 36 yrs W/o Konjengbam Kanchan Singh of Sagolband Tera Bazar near Mamo Pharmacy, Imphal West District, Manipur on which she stated that on 03/03/2026 at around 9:40 am her elder brother-in-law namely Konjengbam Kedarnath Singh aged about 48 yrs S/o K. Muhindro Singh of Sagolband Tera Bazar near Mamo Pharmacy, Imphal West District threw a gas cylinder on her while she was at her room and later destroyed her furniture showing extreme aggression. Also, her younger brother-in-law namely Konjengbam Keny Singh aged about 44 yrs S/o K. Muhindro Singh of Sagolband Tera Bazar near Mamo Pharmacy, Imphal West District had joint the scene and physically assaulted her slapping her face multiple times causing injury and humiliation in front of her family member and neighbor. Later she was rushed to RIMS hospital for medical examination. During enquiry, statement of the complainant has been recorded on which she stated that her family stays at common building sharing with her in laws. Also she stated that her in laws had done multiple violence against her during the absence of her husband. Due to the Incident happen on 03/03/2026 she is still in trauma and under medication having extreme fear of her life. She is now staying at parental home under her parents care and protection. Also, the accused persons are still at large and did not cooperate with the case.

So, I therefore submitted this report for taking further necessary action as per law.
