Dhanabir Singh of Langol Housing Complex, Lamphel, Imphal West, Manipur, lodged a written report with the OC, Lamphel-PS, against Mrs. Huidrom (Ningol) Elangbam Ongbi Dineshpati (40) W/O Elangbam Seilender, resident of Topkhongnangkhang. The written complaint report has been entered into the General Diary of Lamphel Police Station under G.D. Entry No. 31/LPS/2026 dated 09/02/2026 at 05:40 pm, for enquiry to find out the facts of the crime. The OC/Lamphel PS endorsed the same to me for inquiry. As endorsed, I have conducted a discreet inquiry regarding the complaint report registered under the above-referred GD entry No. On inquiry into the complaint report, it is found that on 19/10/2025 at around 08:51 pm, Huidrom (Ningol) Elangbam Ongbi Dineshpati came to the complainant's residence located at Langol Housing Complex and approached her for the use of her jewellery (Earring-7 pairs and Necklace-1, total no. of items 25) worth about Rs. 6,00,000/- (Six Lakhs) approximately for two or three days. Believing her words, the complainant lent her the above-mentioned jewellery items. However, she failed to return the borrowed jewellery items to the complainant despite multiple requests made to her through mobile phone, and she even avoided meeting the complainant. On further inquiry, it has been learnt that the accused person, Huidrom (Ningol) Elangbam Ongbi Dineshpati, dishonestly induced the complainant to deliver her jewellery worth Rs. 6,00,000/- for use for two or three days, but she has misappropriated the complainant's jewellery by converting it into cash through mortgage at jewellery shops. The jewellery of the complainant is still in the custody of the alleged accused person, Huidrom (Ningol) Elangbam Ongbi Dineshpati, without being returned to the complainant. Thus, a cognizable offence under sections 316(2) and 318(4) BNS is made out during the inquiry. Therefore, it is requested to kindly take up necessary legal action against Huidrom (Ningol) Elangbam Ongbi Dineshpati for committing the above-mentioned offence.




