**Subject:** Complaint regarding physical assault

Sir,

I, Soraisam Korounganbi Chanu (20 years), D/o (Late) Soraisam Premkumar Meitei, a resident of Naoremthong Khullem Leikai under Lamphel Police Station, Imphal West District, Manipur, beg to submit the following complaint for your kind consideration and necessary legal action.

That on 11/03/2026, in the morning when I woke up at around 08:15 AM, I found that my mother Padma was not present at home. As my mother had left without cooking any food, I tried to contact her several times by calling her on her mobile number 8837099349, but she did not pick up my calls.

Later, when I contacted my mother's friend Kamala over phone, she informed me that my mother was at the residence of Heikrujam Shanti (46 years), W/o H. Tiken, of Yumjaomanbi Leikai, Game Village, Zone-4, Imphal West, Manipur. Accordingly, I went to the said place between 11:00 AM and 12:00 Noon and found Heikrujam Shanti sleeping there while my mother was trying to leave the place. Upon seeing them, I scolded my mother as I came to know that both of them were drunk.

I requested my mother not to create any scene at another person's residence and asked her to return home with me peacefully. However, while I was trying to convince my mother, Heikrujam Shanti suddenly interfered and started assaulting me by pulling my hair, bending my fingers, and hitting the backside of my head repeatedly and violently. She also dragged me by my hair and threw me onto the ground for about 10-15 minutes. Even when my mother tried to intervene, Heikrujam Shanti did not stop and continued assaulting me.

During the incident, her son also intervened and held me down on the bed, overpowering me. Later, when Heikrujam Shanti's daughter-in-law intervened, the assault temporarily stopped.

Afterwards, I went to the nearby residence of Bijen, which is located next to Heikrujam Shanti's house. From there, I telephoned my sister-in-law, Mathurabashimayum Jelita, and requested help. Accordingly, some of my relatives from the Naoremthong area came to assist me.

In the meantime, Heikrujam Shanti again approached me and started assaulting me in the same manner and also kicked me repeatedly. Later, at around 02:30 PM, when some of my relatives along with my sister-in-law Mathurabashimayum Jelita arrived at the place, Heikrujam Shanti, along with her daughter, daughter-in-law and son, suddenly attacked all of us without any provocation. They started pelting stones, kicking us, and pulling our hair, during which I and some of my relatives sustained severe injuries. During the assault, my sister-in-law Mathurabashimayum Jelita, who was carrying a 3-month foetus, was also kicked by them, as a result of which she sustained injuries. On the same day she started bleeding and later an abortion had to be performed at Irengbam Thamcha Devi Nurshing & Health Care Research Institute & Hospital located at Uripok Khoisnam Leikai, IW.


