I have the honour to state that today i.e. 15/03/2026 at about 10:20 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some miscreants in and around Laipham Khunou area under Lamphel PS with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW assisted by myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Laipham Khunou Mayai Leikai area. During that one suspected person was detained at a house located at Laipham Khunou Mayai Leikai for verification. On spot verification, the detainee identified himself as Sagolshem Boicha Singh (42 yrs) @ Tayai S/o. (L) S. Joykumar Singh of Sawombung Gate, Imphal East District, Manipur.

On thorough verification, he disclosed that he kept concealed a pistol within piles of bricks stored at the outhouse of the said house and as pointed out by him, one 32 pistol marked with "7322" along with one magazine loaded with six rounds of .32 ammunition and one extra magazine loaded with four rounds of .32 ammunitions were recovered.

On asking about the recovered pistol, he disclosed that he bought the above recovered pistol from one Abdul Aziz (Ph. No. 9366114778) of Lilong Ushoipokpi area about three months back by paying a sum of Rs. 70,000/- for the purpose of committing prejudicial activities.




