Sir,
With due respect, I, the undersigned, most humbly submit the following for your kind consideration and necessary action:

That on 20/03/2026 at about 2:00 a.m., my brother, namely Khumanthem Vikram Singh, aged 31 years, along with one Laishram Harly, aged 28 years, was crossing the road at Kwakeithel Thounaojam Leikai near Toll Tax, Imphal West. At that time, a two-wheeler (TVS Jupiter ZX) bearing Registration No. MN06SG-1147, driven by an unknown person, coming from the direction of Kwakeithel Bazar, suddenly and violently hit them due to rash and negligent driving.

That immediately after causing the accident, the said driver fled away from the spot without rendering any assistance to the victims, thereby showing complete disregard for human life and legal responsibility.

As a result of the impact, my brother Khumanthem Vikram Singh sustained grievous injuries and was first evacuated to Asian Hospital for emergency medical treatment. Subsequently, he was referred to Shija Hospital, Langol, where he underwent surgery and is presently under medical observation. As per the attending medical authorities, his condition remains critical and he is in a comatose state.

In view of the above facts, I humbly request you to kindly register a case and take prompt and necessary legal action against the unknown driver of the said vehicle, including efforts to identify and apprehend the accused at the earliest.

I shall remain ever grateful for your prompt action in this matter. Thanking you.
