12. First Information contents

Today, i.e., 25.03.2026, at around 05:50 AM, information was received from the SP-IW Control Room (Mike-30) that on the same day, at around 05:45 AM, an accident had occurred at Kwakeithel Traffic Point between a Tata Magic, red in colour, bearing registration No. MN02G-0396, driven by an unknown driver and proceeding from the Bishnupur side towards Imphal, and a white Swift car bearing registration No. MN06LX-2931, also driven by an unknown driver, which was coming from Khagempaal Road towards Kwakeithel Mayaikoibi. The vehicles collided due to rash and negligent driving on the part of both drivers. As a result, some passengers of the Tata Magic sustained injuries and were evacuated to RIMS Hospital for medical treatment. Both vehicles were badly damaged.

Hence, a regular Suo-Moto case under FIR No. 80(03)2026 LPS U/S-281/125(b)/324(4)-BNS has been registered for investigation
