Subject: Criminal complaint for cheating, fraud and impersonation against Shri Jitendra Meena, newly-recruited Multi-Tasking Staff, in the public recruitment process of RIMS, under CRE-2024, leading to his fraudulent appointment at RIMS, Imphal request for registration of FIR and investigation – reg.

Sir,

I am directed to lodge this criminal complaint against Shri Jitendra Meena, S/o Shri Bajranga Meena, whose address is detailed below. It has been reliably ascertained that an organised racket involving impersonation, fraud and cheating was carried out in the Common Recruitment Examination (CRE), 2024 conducted by the All India Institute of Medical Sciences (AIIMS), New Delhi, at certain examination centres. As a consequence of such illegal acts, Shri Jitendra Meena, has fraudulently secured public employment at the Regional Institute of Medical Sciences (RIMS), Imphal.

2. The facts leading to the filing of the present complaint are stated below:-

- i. Shri Jitendra Meena, S/o Shri Bajranga Meena, resident of V/P-Jeerota, Tehsil-Sapotra, District-Karauli, Rajasthan-322203, applied for the CRE-2024 under Candidate ID No. 4885459828 (Scheduled Tribe category), Date of Birth: 07.06.1996.
- ii. The said examination was conducted on 26.02.2025 at Examination Centre Code 000101, namely ON Digital Zone IDZ1 Patia, Chandaka Industrial Estate, Patia, Bhubaneswar, Odisha-751024 and he was allotted Roll No. 6222855 (Second Shift Session)
- iii. Based on the marks secured in the said examination, the above-named individual was declared successful and was subsequently appointed to the post of Multi-Tasking Staff (MTS) at RIMS, Imphal vide Order No GEN/3/2025-Estt. Sec dated 18.08.2025
- iv. As of part post-selection formalities, Facial/IRIS/Palm/Biometric verification of candidates was conducted on 16.03.2026 at RIMS, Imphal by authorised agencies, namely M/s Tata Consultancy Services (TCS) in association with M/s Innovatiview, engaged by AIIMS, New Delhi
- v. During such verification, it was found that the fingerprint and facial biometric data of Shri Jitendra Meena who joined for duty as MTS at RIMS, Imphal did not match with the biometric data captured at the time of the examination at the aforesaid centre in Bhubaneswar
- vi. The above discrepancy clearly indicates that an unknown person had impersonated the said candidate and appeared in the examination on his behalf, thereby enabling fraudulent selection and appointment.
- vii. The acts constituting the offence have occurred at multiple locations, namely:-
 - a) At the examination Centre at Bhubaneswar, Odisha, where impersonation /proxy appearance was carried out,
 - b) At RIMS, Imphal, Manipur, where the fraud came to light during biometric verification and where the appointment was obtained and acted upon.

3. The individual is presently working/posted in the Office of the Dean (Academics), RIMS, Imphal. The local address furnished by him is: R. Manikchand Singh, Lamambung, RIMS Road, Imphal West, Manipur, Mobile No. 9774878567.



4. In view of the above, it is requested that an FIR may kindly be registered against him under the appropriate provisions of the Bharatiya Nyaya Sanhita (BNS), 2023 at the earliest, and a thorough investigation be undertaken into the matter.

5. The Institute shall extend full cooperation in the investigation. The relevant records, including application details, admit card, biometric data, verification reports, and other supporting documents are enclosed herewith for kind perusal and necessary action.


