Anilchandra Mutum, OC-Commando Imphal East and a team of Sagolmang PS, one team of CDO/IE and 169 Bn. CRPF unit QAT led by Shri Baljinder Singh (Second-in-Command) assisted by Shri Jitendra Kumar. Assistant Commandant along with one platoon of F/169 Bn. CRPF under the supervision of Shri Suresh Kumar, Commandant 169 Bn. CRPF and under the supervision of Shri Y. Joyraj Singh, MPS, Addl. SP(Ops)IE and Shri P. Shankar, MPS Addl. SP(L/O)IE under the overall supervision of Shri. Shivanand Surve, IPS, SP-IE conducted a searched operation at some suspected area of Nungai Hill Range of Chanung about 7:00 am. to 8:30 am. During the search operation, the said combined teams recovered the undernoted articles which were found abandoned at foothill of Nungai Hill Range suspected to be hidden by unknown miscreants.


