Sir,

1. I have the honour to submit you the report that, based on Input received from Chandel Police and corroboration from own source regarding likely presence of War Like Stores (WLS) in general area of Haimol village (SQ 6994) near Indo Myanmar border. A joint operation was launched by a column comprising of strength of 01-01-40 ex COB Molcham and team of Chandel Police (06 pers) with effect from 2200 hours on 15 May 2026 to search the area. Stops were placed and the search party was divided into two groups to thoroughly search the thickly vegetated area near the Indo Myanmar border. After extensive search of the area, at around 0740 hours on 16<sup>th</sup> May 2026, one of the parties found a suspicious patch and on carrying detailed search, a hidden cache containing War Like Stores (WLS) was unearthed at GR 699943. The operation was continued to check for presence of similar caches in the suspected area. After thorough search of the area and no further recovery, the operation was terminated. Details of the items recovered are as follows: -

- 1.1. 01 x MA- 1 Assault Rifle with 01 x Magazine.
- 1.2. 07 x Single Bore Rifles.
- 1.3. 02 x Improvised mortars.
- 1.4. 88 x 7.62 mm rds.
