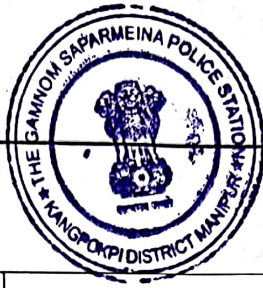

Poonam Pokhrel even burnt utensil until it was hot enough to burn, as soon as people started gathering they ran away from residence. It was came to know even my wife did not interfere as we had verbal fighting regarding petty household issues. My wife Smt Tika Devi Karki is a psychiatric patient since 13 years she used to take sleeping pills more than the doctor advice, which led to over dose. Moreover she consumed alcohol and she could not ascertain to do what to speak. Basically she remains senseless most of the time she was treated at delhi recently. Such physical
