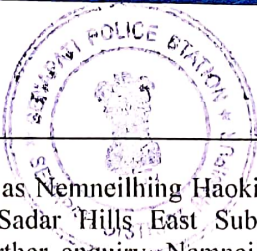

Sir,

I have the honour to state that today i.e. 07/05/2026 @ 7:00 pm, based on reliable source input, combined teams of SDPO-SPT, OC/SPT-PS, SOT (Special Operation Team) Senapati Police, one team from Women Police Station - SPT, one team of 16 AR and D-78 Bn CRPF under the overall supervision of SP – Senapati intercepted one vehicle Bolero bearing Regd. No. NL07C- 5762 at T-Khullen Naka Check point. On enquiry, the driver of the vehicle is identified as K. Dovile (42) yrs s/o A Kapane of Laii Village, Senapati District, Manipur. On checking the vehicle, suspected brown sugar was found concealed besides the radiator of the vehicle. On further enquiry, Dovile stated that the suspected Brown Sugar and the vehicle belongs to Nemneihing Haokip (42) yrs w/o Henkhomang Haokip of Saikul Bazaar Touthang Veng, Sadar Hills East Sub-Division, Senapati, Saikul (now Kangpokpi District), Manipur. K. Dovile revealed that Nemneihing Haokip along with her husband namely Henkhomang Haokip is also coming to Senapati to interchange vehicle which they handed over to K. Dovile in KPI. Following which, the combined team intercepted the said vehicle (Swift) bearing Regd. No. AS04E- 3344 at T-Khullen Naka Check Point. On enquiry, the driver of the vehicle is identified as Henkhomang Haokip (47) yrs H/o Nemneihing Haokip of Saikul Bazaar Touthang Veng, Kangpokpi District



and co-driver is identified as Nemneilhing Haokip (42) yrs w/o Henkhomang Haokip of Saikul Bazaar Touthang Veng, Sadar Hills East Sub-Division, Senapati, Saikul (now Kangpokpi District), Manipur. On further enquiry, Nemneilhing Haokip stated that the suspected brown sugar and the Bolero Vehicle bearing Regd. No. NL07C- 5762 was given to K. Doveli by her. Following which I have informed to my senior officer. As such DC/KPI was intimated by my senior officer and a request was made to depute one magistrate. Accordingly, SDC HQ/EM-KPI Shri. Lhunkhopao Touthang (Executive Magistrate) was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence and in the presence of the drivers namely K. Dovile, Henkhomang Haokip and Co-driver namely Nemneilhing Haokip, the vehicles were thoroughly checked. On checking 99 (Ninety-Nine) soap cases of suspected Brown Sugar were found concealed besides the radiator of the Bolero vehicle.

The 99(Ninety-Nine) suspected soap cases were weighed in the presence of the executive magistrate, the drivers, co-driver and witnesses. The weight of the 99(Ninety-nine) suspected soap cases is 1.140 kg including the plastic covers (without soap cases cover). The approximate value is Rs. 2,28,00,000/- (Two Crore Twenty- Eight lakh). The 99(Ninety-Nine) suspected brown sugar were seized in presence of the Executive Magistrate and witnesses by observing formalities and by preparing a formal seizure memo. The detained persons were formally arrested by observing formalities at 8:30 pm.

Particulars of the seized items:

1. 99(Ninety-Nine) soap cases of suspected Brown Sugar weighing 1.140 kg including plastic covers (without soap case cover) from Bolero Vehicle driven by K. Dovile.

One Service ID Card issued by Manipur Police Department in the name of Henkhomang Haokip having C/No. 8090219 & EIN- 072069 and one mobile phone VIVO T3 Lite 5G having IMEI No. 1: 863675075495387 and IMEI 2: 863675075495395 with Airtel Sim Card No. 8974771220 and Jio SIM Card No. 9863818159 from the possession of Henkhomang Haokip
5. One Realme GT NEO3 having IMEI No. 1: 861174061093556 and IMEI 2: 861174061093549 with Jio Sim Card No. 8798320412 & Airtel Sim Card No.9612786743 from the possession of K. Dovile.
