Subsequently the column ex A coy, 37 Assam Rifles apprehended the individuals at 0745 hrs at Likhai bridge, near Bualkot.

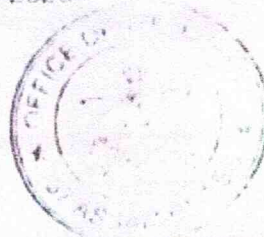


