1. Through sustained efforts to cultivate sources and establish an effective intelligence network, the unit received timely and actionable information from its own sources, which was further corroborated by 11 WEU regarding the transportation of contraband/ drugs. Acting swiftly on the input, a well coordinated joint operation was planned and launched in general area Singngat at 1300 Hr on 03 May 26 by a column of strength 01/00/15 ex 37 Assam Rifles in close coordination with Manipur Police.

2. In pursuance of the operation, a Quick Reaction Team (QRT) from Company Operating Base (COB) Singngat established Mobile Vehicle Check Post (MVCP) along the NH 102B. At approx 1335 Hr, a red coloured Maruti Swift, matching the input description, was intercepted for checking near Singngat. The vehicle and its occupants were subjected to a thorough and systematic search. During the search, a black colored packet was recovered from the trunk of the vehicle. On opening the packet, it was found to contain 27 soap cases of suspected No 4 Heroin following which both the individuals were immediately apprehended.

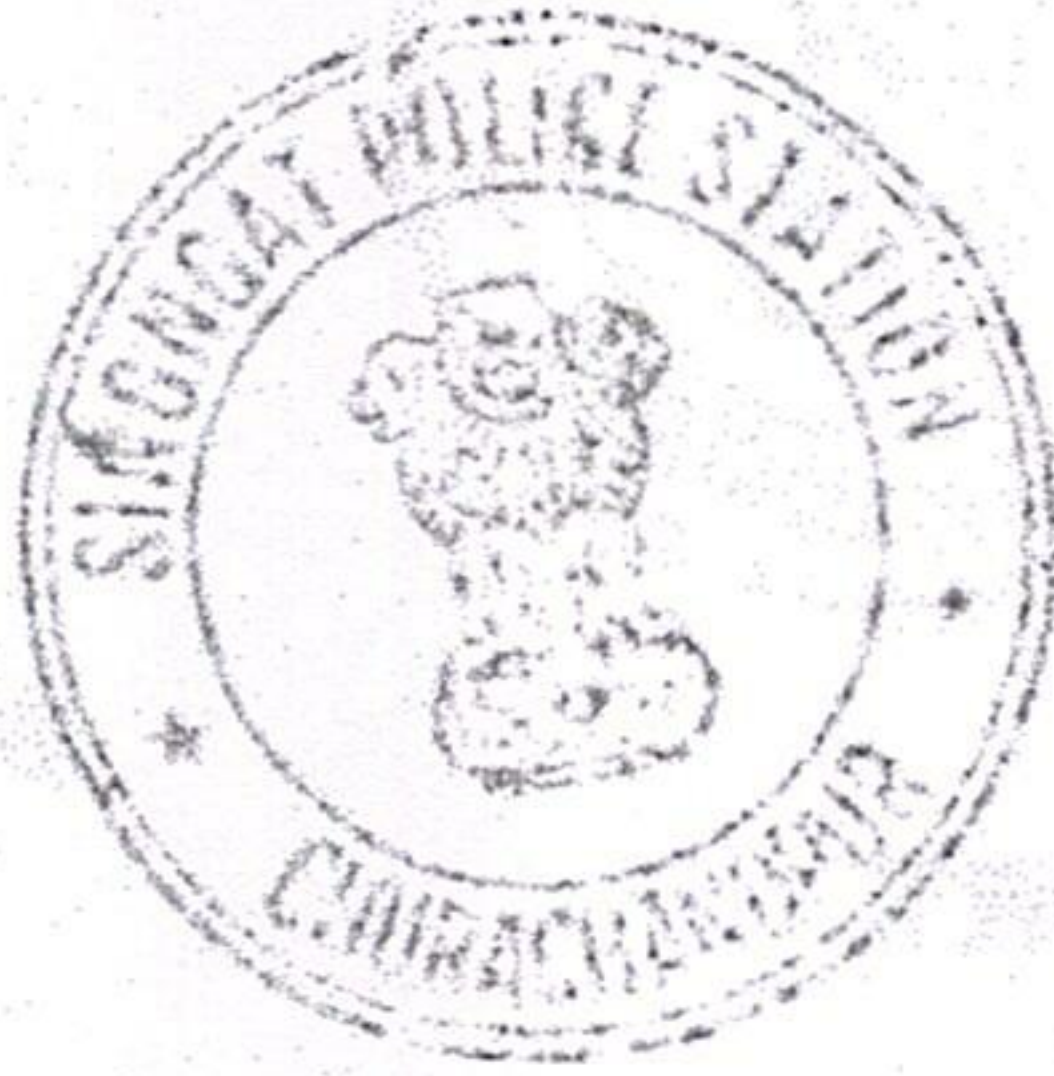
