Today i.e. the 20th May, 2026 at 08:00 a.m. received a reliable input from source that two unknown persons will be transporting illegal drugs consignment in one Kenbo (Myanmar Bike) from Suangdai village along Guite Road towards Churachandpur. Immediately, Executive Magistrate, Singngat Sub-Division was requisitioned for magisterial witness. Self along with a police team conducted frisking and checking at Singngat-PS Nakas Check Post to intercept the Vehicle.

At around 10:30 AM, one Kenbo (Myanmar Bike) coming from Suangdai side was stopped. The vehicle was thoroughly searched in the presence of the Executive Magistrate and recovered 55(fifty five) soap cases containing suspected Brown Sugar packed in one black zip bag.

The suspected Brown Sugar were weighed using a weighing scale and found to be about 2.1 Kgs. including the weight of the soap cases and the plastic packets. 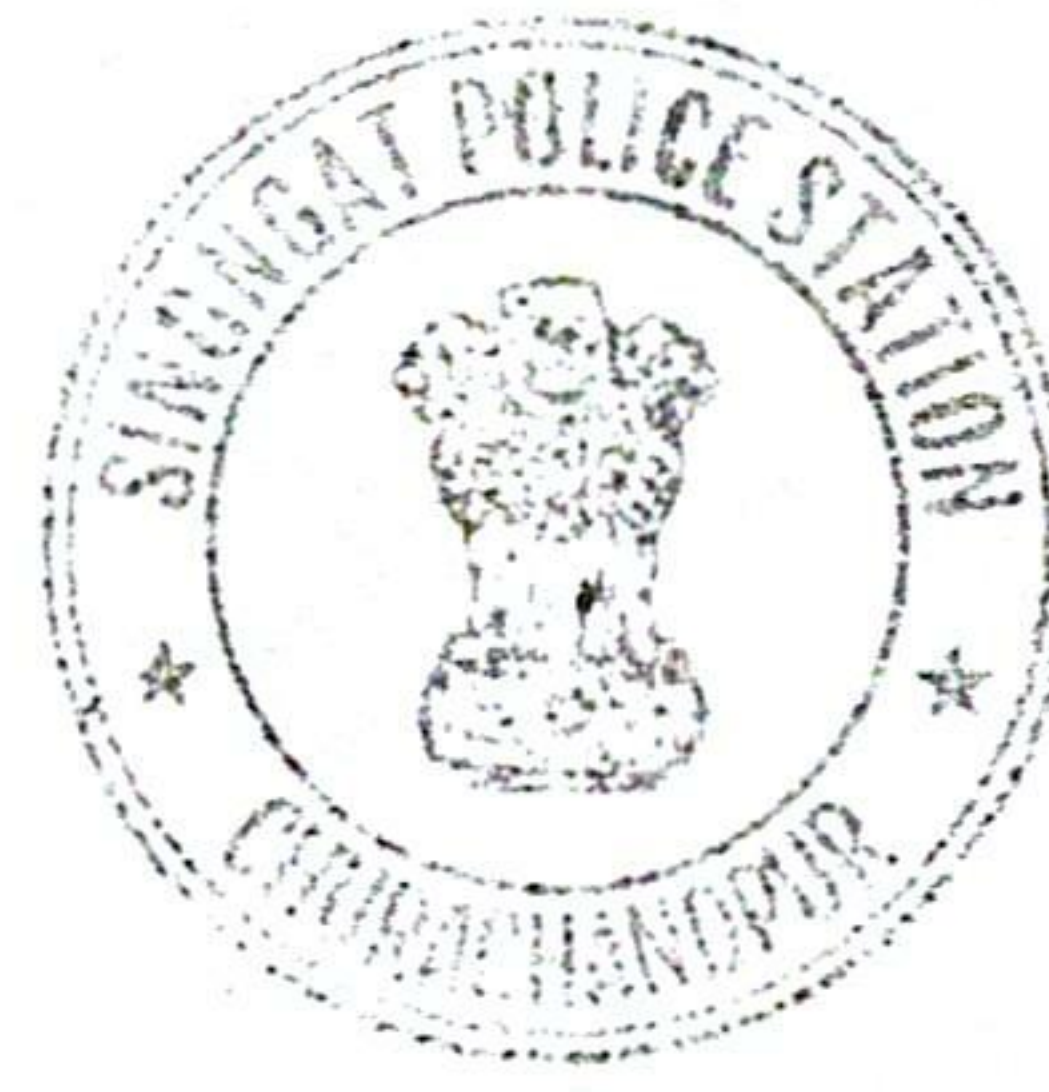
