Sir,

I have the honour to report that on 21st May, 2026 received a reliable input that one unknown person will be transporting drugs consignment from Suangdai Village towards Churachanpur along NH-102B. Acting on the input at 9:30 p.m. self along with OC/SGT-PS and escort party in two vehicles rushed towards Suangdoh Village to setup Temporary Motor Vehicle Check Post and to intercept the drugs consignment.

The following day i.e. 22nd May, 2026 at around 2:30 a.m. one Maruti Ignis bearing registration No. MZ01AD-5474 was seen approaching from Enpum Village towards Churachanpur side. The MVCP party signaled the vehicle to stop but instead fled in full speed. The police party pursued the fleeing vehicle which took diversion from the highway and hid at one old road. The vehicle was found abandoned by the driver with some consignment after fleeing into the jungle. The police party pursued the accused into the jungle and managed to capture and arrest the accused along with some more drugs consignment. On spot interrogation the accused identified himself as Mr. Siamkhansuan (44) Samte S/o. (L) Ginzalal Samte of Gouchinkhup Veng, New Lamka, Churachandpur. And admitted that the 33 Soap cases of suspected brown sugar, 20,000 (twenty thousand) tablets of WY and the vehicle belongs to him. After weighing with weighing scale the 33 soap case if found to weigh 1,364 kgs (including the soap case and wrapping plastic) and the 20,000 (twenty thousand) WY tablets weigh 2,368 kgs (including the wrapping plastics). The drugs consignments along with the vehicle were seized from his possession and the accused arrested.

The Arrested accused along with the seized items are handed over to you for further necessary legal action.
