Sir,

I have the honour to report that today i.e. 08/03/2026 at about 2:40 PM, I was returning home from Kongba after Physiotherapy of my son. While reaching home, an unknown youth was seen trying to steal my Honda Activa, blue in colour bearing regd. no. AS11V-9468, which was parked at the galli of Hotel Jehova Lodge, Paona Bazar Imphal, by using a tool. On seeing me, he managed to escape from the area. I shouted to the passerby and the neighbours for chasing the unknown person and also informed to the police personnel who were on patrolling duty at the area. Then, we chased and overpowered him with the help of the passerby and police personnel and interrogated him. On interrogation, he identified himself as Saleh Khan aged about 28 Years S/O late Ibrahim of Lilong Tairenmakhong, Thoubal District, Manipur. He stated that he came to Paona Bazar, Imphal to steal any two-wheeler vehicle. He tries to steal the said vehicle taking the advantages as there was no any person at that galli. On checking, one bag black in colour containing a cutter, a screw driver and a mobile phone (Oppo) was found from his possession. On checking over the vehicle the lock was found already broken by him using the tools which were found from his possession. Accordingly, he along with the vehicle and a bag were brought to the PS for taking further necessary action.

So, I therefore request you to take necessary legal action against the involved culprit as per law at the earliest.
