Sir,

I have the honour to state that today, i.e., 08/03/2026, at about 5:00 PM, a Cordon and Search Operation (CASO) was conducted at Prajatantra Galli, Thangal Bazar, Imphal under the command of OC, City Police Station, Imphal West, as a preventive measure.

During the CASO, an unknown person who did not possess any identity proof documents was detained for thorough verification. Upon detailed verification, he identified himself as Thoungamba Takhellambam Singh, aged about 27 years, S/o T. Sunil Singh of Kiyamgei Awang Leikai, Imphal East.

During interrogation, he stated that he is an active cadre of PREPAK, an unlawful organization, and that he had joined the organization in March 2025 through one Ningthem of PREPAK and had been staying in Tripura. He further stated that he had come to Imphal for medical treatment. Accordingly, he was brought at the PS and arrested him at 6:45 pm by observing formalities.

So, I requested you to take further necessary legal action against him.
