Subject: - Report.

Sir,

I have the honour to state that today i.e. 13/03/2026 at about 01:10 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KCP (Apunba) organization (a faction of KCP organization) in and around Thangal Bazar area of Imphal West District with a view to commit prejudicial activities. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri P. Achouba Meetei, MPS, Dy. SP (CDO), IW and under the supervision of Shri. N. Suraj Singh, MPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at Thangal Bazar area. During that one suspected person was detained at Thangal Bazar near Kasturi Bridge for verification. On spot verification, the detainee identified himself as Moirangthem Hembra Singh (26 yrs.) @ Laiba S/o. M. Dhamen Singh of Pungdongbam Mayai Leikai, Imphal East District, Manipur.

From his possession, one Redmi Note 7s mobile handset along with one Airtel SIM card bearing mobile no. 8974523807 (as disclosed by him) was recovered.

During preliminary verification, he disclosed that he is an active member of KCP (Apunba) organization (a faction of KCP organization) and joined the said organization in the year 2023 and got Basic Military Training for 12 days in Tentha area under one s/s Corporal Thoiba of KCP (Apunba) organization from Wangoo area. He also disclosed that he is presently working under the command of one s/s Commander Mangal of KCP (Apunba) organization from Wangoi area and he communicated with his commander through Facebook Account: Skus Thoi (belonged to his commander). He further disclosed that under the instruction of his commander, he is involved in extortion activities by serving monetary demands/threats and collecting money from gas agencies located in valley area for raising their party fund and the extorted money were given to his commander. Further, he disclosed that he came to Imphal area for the purpose of committing extortion activities as instructed by his commander.

While the said CDO-IW team was verifying the detainee (Moirangthem Hembra Singh), a mob consisting of women folks and youths started gathering at the spot and due to the suspicion of the mob to obstruct the said CDO-IW team, the detainee might try to flee away from the spot by taking the advantage of the mob. By considering the prevailing law and order situation and sensitiveness of the spot, Moirangthem Hembra Singh was immediately arrested at the spot i.e., at Thangal Bazar near Kasturi Bridge at 03:45 pm by observing formalities.

Due to the mob and the prevailing law and order situation and sensitiveness of the spot, the above recovered article could not be seized at the spot and hence, the arrestee and the above recovered article were brought to CDO-IW Office Complex, Minuthong for making seizure and hence, the above recovered article was seized at CDO-IW Office Complex, Minuthong at 04:33 pm by observing formalities.



Since, there is no mobile number of his family members in the mobile phone of the arrestee to be contacted for giving the information regarding his arrest, and as nominated by the arrestee, his arrest information was intimated through telephonic conversation to his friend namely Wahengbam Ranjan Singh aged about 26 yrs (Ph. No. 6909234939) S/o. (L) W. Itobi of Pungdongbam Mamang Leikai, Imphal East District, Manipur. And his friend was also informed that the arrestee will be handed over to City PS for taking further necessary legal action. Further, his friend was instructed to relay the said arrest information to the family members of the arrestee and his friend was also instructed to make the family members of the arrestee appear at City Police Station for further necessary legal procedure.

Hence, the arrested person and the above seized article are handed over to you for taking further necessary legal action against him.


