Sir,

I have the honour to report that today, i.e., 17/03/2026 at about 5:00 PM, I, along with a police party of City Police Station, was on routine checking and patrolling duty in and around Khwairamband Bazar, Imphal, under the command of Inspector N. Gokulchandra Singh, OC, City PS; under the supervision of N. Ingocha Singh, MPS, SDPO Imphal & Shri Rojit Irom, ASP (L&O), Imphal West, and under the overall supervision of Shri Ksh. Shivakanta Singh, IPS, SP/IW.

During the course of checking and patrolling duty from Khwairamband Bazar towards Khoyathong, Imphal, upon reaching Bora Gali, Thangal Bazar, Imphal, one unknown person was possessing four (04) carton boxes in a suspicious manner. Due to his suspicious behaviour, he was detained for verification.

On verification, he identified himself as Laishram Kunjomani Singh, aged 52 years, S/o (L) L. Tombi Singh, a resident of Iram Siphai Mayai Leikai and presently residing at Sagolband Amudon Akham Leikai, Imphal.

Upon preliminary questioning, he stated that the carton boxes contained medicines belonging to him. However, on further sustained questioning, he admitted that the carton boxes contained contraband substances.

He was informed of his legal right to have the search conducted in the presence of a Magistrate or a Gazetted Officer. He opted for the search to be conducted in the presence of a Gazetted Officer.

Accordingly, the carton boxes were opened in the presence of independent witnesses and Gazetted Officer N. Ingocha Singh, MPS, SDPO Imphal, as well as the Mobile Forensic Team, Imphal West, led by M. Inaobi Singh. Prior to opening, the carton boxes were marked as S1, S2, S3, and S4 for identification.

Upon search, the following items were found:

S1: 60 bundles labeled "SPASMO TUS PLUS" (each bundle containing 18 strips, each strip containing 8 capsules) — total **8,640** capsules.

S2: 60 bundles labeled "SPASMO TUS PLUS" (each bundle containing 18 strips, each strip containing 8 capsules) — total **8,640** capsules.

S3: 114 boxes labeled "SAMPELX +" (each box containing 18 strips, each strip containing 8 capsules) — total **16,416** capsules.

S4: 98 boxes labeled "SPASMO TUS PLUS" (each box containing 30 strips, each strip containing 8 capsules) — total **23,520** capsules.

The total No. of Capsules is 57,216/-.

In addition, one Nokia keypad mobile phone was also recovered.

All the above items were seized from the possession of the said individual in the presence of the Gazetted Officer, Mobile Forensic Team, Imphal West, and independent witnesses at 7:40 PM by preparing a proper seizure memo. The seized items were duly packed and sealed using a wax seal in the presence of the independent witnesses, the accused person, and the Gazetted Officer.

So, the accused person namely Laishram Kunjomani Singh, 52 yrs. S/o (L) L. Tombi Singh of Iram Siphai Mayai Leikai, A/P Sagolband Amudon Akham Leikai, Imphal was arrested at the spot at 7:55 pm by observing formalities for possessing illicit items without any valid documents.



The arrested person and the seized articles are handed over to you for taking further necessary legal action.
