Sir,

I, the undersigned, Mayanglambam Rebika Devi aged about 38 years, W/O., Gagandeep Singh, of Thangal Bazar, P.O.Imphal, P.S. City, Imphal West, District, Manipur, have the honour to submit the following for your sympathetic consideration and immediate necessary actions:-

1. That, the accused person namely Kshetrimayum Sarjulata Devi is unlawful wife (second Wife) of Gagandeep Singh and Thokchom Nitika who is daughter of Sarjulata Devi from her first husband.
2. That, my younger sister namely Ritika Mayanglambam is staying with me at my residence at Thangal Bazar as I live on the top floor along with my two minor daughters. She used to go out for home tutor.
3. That, earlier the above mentioned accused persons along with my husband Gagandeep Singh had always caused physical and mental harassment to me and my minor daughters.
4. That, on 18-03-2026 at about 4:00 p.m. my sister is about to go for home tutoring, the above name accused persons call her "Kasubi" (Whore). Then, the accused persons intentionally throw cat's faecus over my sister when she is about to go for home tutoring. whenever she went out for work
5. That, when my sister confronted the accused persons over the throwing of cat's faeces, they started to assault my sister with iron rod and deadly weapon.
6. That, when I try to stop the quarrel between them, the accused persons also assault me with iron rod. Moreover, they also molested me and my sister.
7. That, if the accused persons are not arrested and punished according to law as soon as possible, the complainant will suffer irreparable injuries.

In the above referred circumstances, it is therefore, prayed that your good self be please to take cognizance of the offence and arrest the accused persons who are involved in the case, as soon as possible in order to prevent from unwanted incident, for the interest of justice.
