Subject: Complaint regarding armed intimidation, vandalism and death threats by KNF (SoO) Cadres at Ireng Naga Village.

Sir,

The Ireng Naga Village Authority hereby lodges this formal complaint regarding grave criminal acts committed by armed cadres of the Kuki National Front (KNF), a Suspension of Operations (SoO) group under UPF, against the peaceful residents of Ireng Naga Village. On the night of 11 January 2026 at around 11:30 pm armed KNF/UPF cadres in combat uniform illegally entered Ireng Naga Village, vandalized public property, destroyed a community waiting shed, and defaced the village memorial stone by writing "Kukiland" and "Stay away" these acts amount to criminal trespass, mischief, and deliberate ethnic intimidation.

On 12 January 2026, after villagers held a peaceful road blocked seeking protection, One Tiger Kipgen (Thangboi/Haogenthang Kipgen), reportedly a KNF commander, contacted the village chairman via whatsapp and mobile calls at 12:05pm and issued explicit threats of open gunfire and burning down the entire village. Later, on the same day at about 2:01 pm 30-40 heavily armed cadres were sighted advancing towards the village, causing panic and fear of imminent attack.

We request immediate registration of FIR under relevant IPC and UAPA provision, urgent security deployment to protect civilians, and legal action against all involved. Delay may result in serious loss of life and public order.

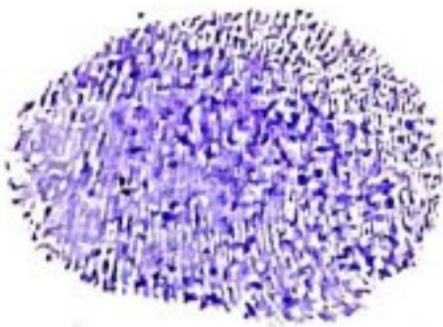
