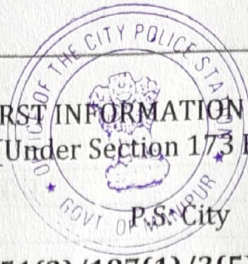



12. First Information contents:

Today, i.e., 31/03/2026 at about 6:30 PM, reliable information was received to the effect that at around 6:25 PM on the same day, a press briefing was organised by one Malem Thongam of Maiba Khul, Imphal East District, a social activist along with Thokchom (o) Konsam (N) Haripriya of Kwakeithel Makha Thokchom Leikai, Oinam Inaocha of Singjamei Thongam Leikai, Somi and Sangeeta who are members of the group "Ima gi Meira," along with other associates in front of the gate of the Traffic Control Police Wing, Thangal Bazar, Imphal.

During the said press briefing, statements were made alleging that the Government of Manipur has failed to provide free passage on the National Highways for the Meitei community. The content of the briefing, as observed and as circulated through video footage, appears to contain elements of criminal intimidation and promotes enmity, hatred, or distrust among different social groups. Furthermore, the statements are found to be of such nature that they may involve dissemination of false or misleading information, thereby posing a potential threat to public order and jeopardising the sovereignty, unity, integrity, and security of the State.

In view of the above, a suo motu case has been registered vide FIR No. 24(03)2026 of City Police Station under Sections 351(3)/197(1)/3(5) of the Bharatiya Nyaya Sanhita for the purpose of investigation.


