Sir,

I have the honour to report that I have been threatened and subjected to an attempt of extortion of a sum of Rs. 1,25,00,000/- (Rupees One Crore Twenty-Five Lakhs) by the following persons:

- (1) Shankar Lal Agarwal S/o Narayan Agarwal (Mob: 9334382498)
- (2) Rishabh Agarwal S/o Shankar Lal Agarwal (Mob: 7903068583)
- (3) Rakesh Kumar Agarwal S/o Jagdish Chandra Agarwal (Mob: 9334388400)

All are residents of 41, Rajendra Nagar Colony, Sakchi, P.O. & P.S. Sakchi, Town Jamshedpur, District East Singhbhum, Jharkhand.

They have been making repeated threats over mobile phone while I was at my residence. That, the above-named persons have falsely and maliciously alleged that I visited their residence on 25/10/2025 and in April 2024 and issued a fabricated money receipt and threatened them. These allegations are completely false and baseless. I have never visited their residence nor do I know them personally.

That, the accused persons, with mala fide intention, have falsely implicated me in a criminal matter and are demanding illegal monetary payment over phone, which clearly amounts to extortion.

That, they are continuously threatening me that if their unlawful demands are not fulfilled, they will implicate me and my family in false criminal cases at Jamshedpur, causing serious consequences.

That, the acts of the accused persons amount to criminal intimidation, extortion, false accusation, and criminal conspiracy, causing me severe mental agony, loss of reputation, and insecurity.

Therefore, I request you to kindly register an FIR against the accused persons under appropriate sections of the Bharatiya Nyaya Sanhita including: Section 308 BNS – Extortion, Section 351 BNS – Criminal Intimidation, Section 248 BNS – False charge of offence made with intent to injure, Section 61 BNS – Criminal Conspiracy and take necessary legal action in accordance with law. It is also requested that necessary steps be taken to ensure the safety and security of me and my family.


