

12. First Information contents:

Today, i.e., 07/04/2026 at 3:54 pm, received an information that on the same day at around 3:50 pm, a groups of unruly mobs mainly unknown youths held a protest by burning effigy of Hon'ble Chief Minister of Manipur at Shamu Makhong, Khwairamband Keithel, Imphal regarding a brutal killing of two minor children at Tronglaobi, Bishnupur District Manipur by a bomb attack of the suspected Kuki militants. Further the unruly mob dismantled the barracked and police booth of TCP-IW installed at that area and also a police booth of CDO-IW installed at Hao Keithel Machin was set on fire, by violating the prohibitory order promulgated by the District Magistrate, Imphal West, vide Cril. Misc. Case No. 5 of 2026 dated 7th April, 2026, issued under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023. The police party and CAPF personnel dispersed the unruly mob by using minimum force with an order of the Executive Magistrate, IW.

Hence, a suo motu case vide FIR No. 28(04)2026 City-PS U/s. 189(2)/223/324(3)/326(f) BNS has been registered for investigation.


