That, on 3rd May, 2023 at around 09:00 P.M (night) I along with my family members were forcefully displaced from my residence being House No. 52 situated at Leimakhong Mission Veng, due to the conflict that started on 3rd May, 2023 started by Meitei Militant called Arambai Tenggol. My said property lies in the buffer zone and it includes my home, School building (Keystone English Junior High School) and other properties which was totally looted, vandalised and destroyed by unknown persons suspected to be the said meitei militants in my absence. I was informed by some well wisher on 19-11-2025 @ 2 P.M that all my properties including my said home, houses, school buildings and properties etc. were completely

looted, vandalised and destroyed by the said unknown persons which may be totally valued about Rs. 3,57,00,000/-(Rupees. Three Crore and Fifty Seven Lakhs only) (approx.).

2. That, I herewith humbly submitted that the incident deeply traumatised me and as a result I suffered from several critical diseases such as diabetetic, Eye Operation, Heart Attack twice and I also underwent Cardiac Operation outside the state of Manipur along with several seasonal ailments. I also undergo medical treatment till date. Apart from struggling for survival in this present conflict, I am fighting for my life from the above mentioned diseases which is getting worsen and worsen day by day till date. As such, I am filing this complaint report for necessary action.
