


12. First Information contents:

Today, i.e., 25/04/2026 at 2:30 pm, information was received that on the same day at around 02:25 pm, several groups of unruly mobs comprising men and women had started an unlawful assembly at Khwairamband Ima Keithel surrounding areas, Imphal. The gathering was organised by COCOMI (The Coordinating Committee on Manipur Integrity) and demanding action against Kuki Narco Terrorist, Proxy War, Tronglaobi and Kasom Khulen incident, IDPs, SoO abrogation and the implementation of NRC thereby violating the prohibitory order promulgated by the District Magistrate, Imphal West, vide Cril. Misc. Case No. 5 of 2026 dated 7th April, 2026, issued under Section 163 of the Bharatiya Nagarik Suraksha Sanhita, 2023. One person namely Somorjit, Ex-President of DESAM (The Democratic Students' Alliance of Manipur) was assaulted by the unruly mobs at Khwairamband Ima Keithel, Imphal.

In this connection, the Executive Magistrate along with the police party attempted to pacify the protesters and warned them to disperse, explaining the promulgation of the prohibitory order issued by the District Magistrate, Imphal West in the area. However, the protesters did not heed the warning instead they became more aggressive and provoked the police personnel while obstructing them from the lawful discharge of their duties. Having no other option, the police party, along with CAPF personnel under the orders of the Executive Magistrate, dispersed the unruly mob by using minimum necessary force and one VDF No. V112969 P. Rojen Singh received injured on his body.

Hence, a suo motu case vide FIR No. 33(4)2026 City-PS U/S 191(2)/190/223/132/117(2) BNS has been registered for investigation.


