Subject: Report.



Sir,

I have the honour to state that today i.e. 01/05/2026 @ 2:00 pm, while conducting a random frisking and checking at Kabinam village along NH-2, 4 Kms South of Maram PS. A joint team of Senapati Police SOT (Special Operation Team), QAT B/109 Bn. CRPF, one colum of 16th AR, BN, HQ, Maram and one team of Maram Police Station, one vehicle Scorpio black colour bearing Reg. No. NL07CD7347 was seen coming from Senapati towards Mao. The said vehicle was stopped for frisking and checking. On enquiry, the driver of the vehicle is identified as Manglenthang Tuboi (23) yrs s/o Thangjalun Tuboi of Saikul Bazar PO/PS- Saikul, Kangpokpi District Manipur. On checking the vehicle suspected to be brown sugar was found concealed at the back of rear seat of the vehicle. As such DC/SPT was intimated by my senior officer and a request was made to depute one Magistrate. Accordingly, SDC/BDO, Lairouching Shri. James Panii (Executive Magistrate), of Senapati was deputed for doing the necessary procedures.

On arrival of the Executive Magistrate and in his presence the said driver namely Manglenthang Tuboi (23) s/o Thangjalun Tuboi of Saikul Bazar PO/PS- Saikul, Kangpokpi District Manipur the vehicle was thoroughly checked. On checking, 40 (Forty) soap cases of suspected to be brown sugar were found concealed at the back of rear seat of the vehicle.

The 40 (Forty) soap cases suspected to be brown sugar were weighed by using weighing machine in the presence of the Executive Magistrate and witnesses and weighed 0.551 kg. including the weight of transparent plastic (without soap case cover). The approximate value is Rs. 1,10,20,000 (One crore ten lakhs and twenty thousands). The 40 (Forty) soap cases of suspected to be brown sugar were seized in the presence of the Executive Magistrate and witnesses by preparing a formal seizure memo. The detained person namely Manglenthang Tuboi (23) s/o Thangjalun Tuboi of Saikul Bazar PO/PS- Saikul, Kangpokpi District Manipur was formally arrested by observing formalities at 3:10 pm.

Particulars of the seized items:

2. 40 (Forty) soap cases suspected to be brown sugar weighing 0.551 kg. including the weight of transparent plastic (without soap case cover).

5. 01 (One) POCO M2 Pro mobile handset along with one Jio sim card 9366802733

Therefore the seize items along with the arrested accused person were handed over to OC/MRM-PS for further legal action.
